On behalf of Acting Federal Housing Administration (FHA) Commissioner Carole Galante, this is in response to your letter of October 26, 2011, concerning Montgomery County's Inclusionary Zoning Program, the Moderately Priced Dwelling Unit (MPDU) Program, and its eligibility on FHA insured loans.

FHA has now completed its review of the MPDU program requirements, including calculation of a Maximum Resale Price. Based upon Montgomery County's representations and submitted documentation concerning the MPDU program requirements and their relationship to FHA's requirements, FHA is satisfied that the MPDU program requirements do not violate Affordable Housing Requirements codified in Code of Federal Regulations §203.41.

Please be advised that FHA is currently evaluating Affordable Housing requirements so that greater clarity can be provided regarding use of these programs in conjunction with FHA insured loans. However, unless and until further guidance is announced for determining a reasonable share of the appreciation in value upon resale, FHA deems units subject to the Montgomery County MPDU program as eligible for FHA insurance.
